In a world where lifestyle decisions have far-reaching implications for the environment, it's important to know that real fur is among nature's most ecologically sound products.

- **Fur sold in the U.S. comes only from plentiful species**, either raised on farms or trapped under the strict regulation of state governments. In fact, thanks to the efforts of skilled farmers, trappers and dedicated wildlife professionals, America's furbearer populations are more numerous today than at any time in our history.
- From start to finish, **fur production involves virtually no waste**, an important element of the conservation ethic. Farm-raised furbearers consume farm byproducts not suitable for human consumption, and that otherwise would require costly landfill disposal. In turn, the byproducts of fur farming are used to produce animal feed, pet foods and fine hypoallergenic soaps and cosmetics.
- **Fur products can last a lifetime** if well cared for, but when the time finally comes to dispose of them, it is reassuring to know that they are biodegradable. Think of that the next time you throw away an item of synthetic clothing made from petroleum. Unlike oil, fur is also a renewable natural resource.
- Last but by no means least, **America's fur farmers are committed to providing their animals with humane care**. This is not just because they have strong ethics. It is also good business sense. Furbearers need quality care if they are to produce quality fur, and American mink have become a standard for excellence world-wide.
